



This is our second publication of the Directory of Federal Audit Organizations. It is intended to aid in the development of intergovernmental cooperation by facilitating the interchange of information among audit groups.

In compiling this Directory, we included only those audit groups directly involved in the audit of Federal funds. This encompassed all agency internal audit groups, as well as those external audit groups assigned to audit Federal assistance programs. We did not include external audit groups whose primary mission is to determine compliance with laws and regulations. This excluded mainly the external audit organizations within regulatory agencies.

As a service to the audit community, we intend to update and publish the Directory annually. Therefore, users of this Directory are invited to comment on its usefulness and any corrections which should be made. Also, if any audit groups were inadvertently omitted and would like to be included in the next edition, let us know. Comments should be sent to George L. SUMMARY OF FEDERAL AUDIT ORGANIZATIONS

LOCATION IN ORGANIZATION

Of the 50 audit groups listed in the directory, the audit directors of 16 report directly to the heads of their respective agencies. For example, the Director of the Defense Contract Audit Agency reports directly to the Secretary of Defense.

The most popular organizational arrangement of audit groups is where the audit director reports to an individual one level below the agency head, generally the Assistant Secretary level. For example, the Director of the Office of Audit at the Department of Agriculture reports to the Assistant Secretary for Policy, Budget and Administration, who reports directly to the Secretary of Agriculture. Twenty-six out of 50 audit groups have this type of organizational placement.

There are eight audit groups reporting to an individual located more than one level below the heads of their respective agencies. An example of this type of organizational placement is within the Veterans Administration, where the audit director reports to an individual who is four levels below the agency head. The Director of the Internal Audit Service reports to the Assistant Administrator of the Office of Planning and Evaluation, who reports to the Associate Deputy Administrator, who reports to the Deputy Administrator, who reports to the Administrator.

STAFF SIZE

During fiscal year 1976 there were over 16,500 audit personnel in the Federal Government, including support staff. This figure represents a slight decrease in staff size from the previous year despite the growth of the Federal budget.

The sizes of the audit groups ranged from one individual in the Federal Communications Commission to 5,167 in the General Accounting Office. Nine audit groups had 84 percent of the audit staff, as shown below:

FUNDING

Over \$423 million was provided for the operation of the audit groups during fiscal year 1976. This is one-tenth of 1 percent of the total Federal budget. Amounts ranged from \$27 thousand to over \$135 million to fund each audit group. The funding range for each audit group was as follows:
